## JOINT ENTERPRISE CONTRACTED LOGISTICS AND SERVICES SUPPORT (JE-CLaSS) II

The Joint Enterprise Contracted Logistics and Services Support (JE-CLaSS) II is a Joint Program Executive Office for Chemical, Biological, Radiological and Nuclear Defense (JPEO-CBRND) enterprise-wide Multiple Award, Indefinite Delivery/Indefinite Quantity (MA IDIQ) contract designed to promote maximum flexibility as well as a streamlined and efficient process for awarding task orders based on mission requirements. Thirty highly qualified contractors have been awarded an IDIQ contract. These IDIQ contract holders will compete on future requirements as specified in Task Orders to provide CLS, PBL, acquisition logistics, training, and related services in support of CBRNE systems and equipment across two domains.

### DOMAIN I

Open to Large and Small Businesses, will provide the full spectrum of CLS, training and sustainment execution to include, but not limited to: Program Management and Administration; Logistics/Supportability Services such as System Maintenance and Reset to include Field Maintenance Support; Supply Chain Management and Support to include Requisitioning, Stocking and Reporting, Logistics and Warehousing, Calibration, Monitoring Shelf Life, Product Support Assessments and Analysis, Performing Training (to include develop, modify, integrate and implement task order-specific equipment/system/other training), Total Package Fielding, Transport of Equipment and Materials, Provisioning, and Product Support Analysis; Fielding Support; Engineering Services; Quality Assurance; Security; and Environmental, Safety and Occupational Health (ESOH).

### DOMAIN II

Small Business Set-Aside, will provide acquisition logistics services such as, but not limited to, planning, development, analysis, review and/or update of logistics studies, analyses and program documentation for logistics and sustainment needs. It includes but is not limited to: Acquisition Logistics Services and product Supportability/Sustainability Support, Training planning and support (to include, but not limited to, concepts, strategies and scenario development, exercises, product development and other training support), Program Management, Administration and Reporting; Property Accountability, Quality Assurance; Security; and ESOH.

## CONTRACT AND TASK ORDER INFO

- Ordering Period** → Four (4) years with an optional four (4) year extension; performance may extend an additional three (3) years. Orders may be placed up to and including the final day of each ordering period.
- Contract Ceiling** → \$906,570,000.00
- Task Orders Types** → May utilize Firm-Fixed Price (FFP), Fixed Price Incentive (FPI), Cost-Reimbursement, Cost-Plus-Fixed-Fee (CPFF), Cost-Plus-Incentive-Fee (CPIF) contract types, or any combination thereof.
- Performance Places** → Performance locations include the Continental United States (CONUS) and Outside the Continental United States (OCONUS) locations as identified in individual TOs.
- IDIQ Contracts** → Currently (23 Domain I, 18 Domain II Contracts. Projected Task Orders will be released and awarded to JE-CLaSS II IDIQ Holders Only. IDIQ Holders can partner with any company within or outside the JE-CLaSS IDIQ contract
